## **DUI FACTS**

**FACT: On average, your first offense for DUI with no accident will cost you about \$9,500.**

*Most people think a DUI will cost them \$300 in fines and a slap on the hand. Those people have forgotten about: the \$450 impound fee, the raised insurance premiums, the time you must take off to show up in court for the preliminary hearing and the jury trial, the \$900 fine, the \$1000 mandatory 6 week- DUI class, the time you must take off work to pick up trash on the side of the road, and the embarrassment.*

*If you make more than \$50,000 a year, your figure goes up even more.*

**FACT: If you are found to be under the influence at a crash someone else caused, you will still go to jail.**

*Many DUI drivers who are obeying all traffic laws can be hit by sober drivers who just made a driving mistake. At the accident scene, the police will take you to jail if you are DUI even if the accident was not your fault. If you are DUI, pray you don't get rear ended by a sober driver.*

**FACT: You do not have to be drunk to get arrested for DUI**

*When you have been drinking alcoholic beverages and have that **buzzed feeling** that is a good time to call Safe Ride Solutions. Remember driving buzzed is driving DUI. If you are impaired, you are DUI.*

**FACT: If you are DUI and end up hurting someone, you are going to be arrested for a felony.**

*Any injury resulting from your impaired driving is a felony DUI, including minor passenger injuries in your car. You will have to worry about jail, lawyers, trials, criminal prosecution, suspended license, and the civil case from the other party who is suing you for damages. Your life is about to get very difficult. If you kill someone accidentally, you are going to prison.*

**FACT: You can get arrested for driving under the influence of prescription and non prescription drugs**

*People that have not had one sip of alcohol get arrested every day for DUI. If the drugs you are taking cause you to operate your car in an unsafe manner or if it impairs your driving in any way, you will be arrested.*

**FACT: You do not have to be actively driving your car to get arrested for DUI**

*In most states, once you are under the influence of alcohol or drugs and have control of a vehicle, you are subject to arrest for DUI. Seated behind the wheel of a parked car while under the influence will get you arrested in most states. Don't*

*even sit in the driver's seat. We recommend once you have been drinking stay away from your car until we get there.*

**FACT: You can be under the legal limit and still go to jail.**

*In most states, once you are under the influence of alcohol or drugs, law enforcement authorities only have to show your driving ability was severely impaired by the amount of alcohol you had. For example, the legal limit in California is .08%. If you are .06% but you cannot pass a field sobriety test, you can still go to jail if the cops show impairment on your part. They will probably presume you have drugs in your system in addition to alcohol. Again, you can go to jail.*

*If you are under the legal drinking age, there is zero tolerance. You will lose the ability to get a license for a long time if you are found with alcohol in your system while operating a motor vehicle. SRS does not support underage drinking and cannot provide service to anyone under the age of 21.*

**FACT: DUI happens all the time and most never take it seriously until it's too late**

*Alcohol-related motor vehicle crashes kill someone every 31 minutes and an alcohol –related injury crash injures someone every two minutes (NHTSA 2006)*

*During 2005, 16,885 people in the U.S. died in alcohol-related motor vehicle crashes, representing 39% of all traffic-related deaths (NHTSA 2006).*

*In 2005, nearly 1.4 million drivers were arrested for driving under the influence of alcohol or narcotics (Department of Justice 2005). That's less than one percent of the 159 million self-reported episodes of alcohol-impaired driving among U.S. adults each year (Quinlan et al. 2005)*

**FACT: DUI is 100% preventable now with SRS**
